- 3) **Adoption of Agenda:** Motion by Trustee Kaminski, seconded by Trustee Stew Swanson, that the agenda be adopted as presented. Vote: Ayes: 5. Motion carried.
- 4) **Minutes Approval:** Motion by Trustee Kaminski, seconded by Trustee Stew Swanson, that the minutes of the public hearing and regular meeting of November 17th be approved as presented. Vote: Ayes: 5. Motion carried.

- 9) **Appointment of 2016/2017 Election Inspectors:** Motion by Trustee Kaminski, seconded by Trustee Stew Swanson, to accept the appointment of Election Inspectors for the term 2-year term beginning January 1, 2016 and ending December 31, 2017 as presented by President Deschane. Discussion: The board thanked Helen Franzen and Dorothy Franzen for their many, many years of service. Vote: Ayes: 6. Motion carried.
- 10) **Don Brooks Park Project - Richlen Excavating Invoice:** (Public Works) Motion by Trustee Franzen, seconded by Trustee Duane Swanson, to approve payment of the final invoice for the Don Brooks Park project to Richlen Excavating in the amount of \$24,985.82. Vote: Ayes: 6. Motion carried.
- 11) **General Equipment Savings Withdrawal:** (Finance) Motion by Trustee Kaminski, seconded by Trustee Stew Swanson, to approve a withdrawal from the General Equipment savings fund of \$5,200.00 for fire department equipment for new members. Vote: Ayes: 6. Motion carried.
- 12) **Approval of Committed Fund Balance:** (Finance) Motion by Trustee Kaminski, seconded by Trustee Stew Swanson, to approve the balance of the committed (designated) fund as of 11/30/2015. Vote: Ayes: 6. Motion carried.
- 13) **2015 Budget Adjustments for General & TIF Funds:** (Finance) Motion by Trustee Kaminski, seconded by Trustee Stew Swanson, to accept the final 2015 budget adjustments to the General and TIF funds. Vote: Ayes: 6. Motion carried.
- 14) **2016 Voting Machine Maintenance Agreement:** (Finance) Motion by Trustee Kaminski, seconded by Trustee Stew Swanson, to accept the 2016 voting machine maintenance agreement with Command Central. Vote: Ayes: 6. Motion carried.
- 15) **Operators Licenses:** (Finance) Motion by Trustee Kaminski, seconded by Trustee Stew Swanson, to grant an operators license to Angela Ellis, who has received a satisfactory background check, effective 12/15/15 through 6/30/16. Vote: Ayes: 6. Motion carried.
- 16) **Recess to Closed Session:** Motion by Trustee Franzen, seconded by Trustee Kostuch, to recess to closed session pursuant to Wis. Statute section 19.85(1)(g) to confer with legal counsel who is rendering oral or written advice concerning strategy to be adopted with respect to the Crivitz Waterway Project lawsuit. - Pres. Deschane stated: Closed session is in accordance with WI Statute sec. 19.85(1)(g) which states that "...any meeting of a...governmental body, upon motion duly made and carried, may be convened in closed session under one or more of the exemptions provided in this section...(g)...conferring with legal counsel for the governmental body who is rendering oral or written advice concerning strategy to be adopted by the body with respect to litigation in which it is or is likely to become involved."
- 17) **Reconvene in Open Session:** Motion by Trustee Kostuch, seconded by Trustee Franzen, to reconvene in open session pursuant to Wis. Statute section 19.85(s) immediately after the conclusion of the closed session to take possible action concerning the subject of the closed session including but no limited to the next two agenda items. Vote: Ayes: 6. Motion carried. Pres. Deschane announced that there was no action taken in closed session.
- 18) **Approval of Waterway Improvement and Maintenance Easement with Crivitz Gateway, Limited:** Bypassed.
