5) **Public Input on Proposed Extraterritorial Zoning Ordinance and Groundwater Protection Overlay District:**

Shirley Prudhomme asked what constituted an animal unit. The answer appears on page 3 of the ordinance, where it states an animal unit is defined per WisDNR, being that one animal unit is equal to 1,000 pounds of live weight.

Elaine Olson asked for clarification on Town representative voting input as to conditional use permits. In Section 1 the Town and Village are given an equal number of members on the Development Committee, which according to section 13-1-62(j) has exclusive authority to approve or deny conditional use permit applications.
